INSTRUCTIONS FOR USE

When and where to use:

A broad spectrum insecticide for the control of insect pests such as aphids and caterpillars on roses and a range of garden vegetables, Py Bug Killer Concentrate will also control beetles on specified vegetables. Do not apply when bees are actively foraging (use early in the morning or late in the evening).

How to use:

SHAKE WELL BEFORE USE

Add the required amount of product to water and agitate to ensure thorough mixing. To be applied with a knapsack or pressurised garden sprayer. Spray plants thoroughly, including the underside of the leaves.


